

Official Rules for the Canlis Friday Night Bingo Giveaway (“Official Rules”)

NO PURCHASE IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE DOES NOT INCREASE YOUR CHANCE OF WINNING.

ELIBILITY. The **Canlis Friday Night Bingo promotional giveaway** (“Friday Night Bingo”) is open to all legal residents of Washington state who are 18 years of age or older at the time of entry, except for the following individuals: (a) employees, officers, directors, agents, and representatives of Canlis Inc. (“Canlis”) and its affiliates, subsidiaries, distributors, suppliers, advertising, and giveaway agencies (“Excluded Individuals”); (b) the immediate family members (mother, father, sister, brother, child, husband, wife and their respective spouses, regardless of where they reside) of Excluded Individuals; and (c) persons living in the same household as Excluded Individuals—whether or not they are related. The Friday Night Bingo is void where prohibited by law; all applicable federal, state, and local laws apply.

Throughout the Giveaway Period, Canlis will distribute a bingo card to each eligible participant that completes the entry steps described below to receive a bingo card and enter the Friday Night Bingo. Canlis will livestream Friday Night Bingo each Friday at 8:30pm Pacific Standard Time during the Giveaway Period to announce the randomly generated bingo numbers. The first eligible participant to text to (480) 702-1978 a picture of a Canlis bingo card showing a line of numbers called randomly by Canlis during that particular livestream event that shows the eligible participant’s bingo card with five numbers in a diagonal, horizontal, or vertical row (the “Winner”) will receive the Prize.

CONTEST DATE(S). There will be Friday Night Bingo livestream events held at 8:30 pm Pacific Standard Time on April 24, 2020, May 1, 2020, and May 8, 2020, and one Winner will win one Prize at each livestream event. The Giveaway Period begins at 5:00 pm Pacific Standard Time on April 20, 2020, and ends at 11:59 pm Pacific Standard Time on May 8, 2020 (the “Giveaway Period”).

ENTRY. Eligible participants will receive a Canlis bingo card by using one of the following options:

3.1. Purchase a Canlis Family Meal, CSA box, or Bottle Service; or

3.2. Print your complete name and e-mail address on a plain 3” x 5” piece of paper or postcard, and mail it to: Canlis Inc, 2576 Aurora Avenue N., Seattle, WA 98109.

All entries must be submitted within the Giveaway Period. No entries submitted via automated reproduction will be accepted. Canlis assumes no liability for lost, late, incomplete, or misdirected entries or bingo cards. Entry is limited to one per person.

By participating in Friday Night Bingo, you agree to abide by these Official Rules.

PRIZES. Canlis will give away one Canlis CSA box (valued between \$80-120 depending on contents of box), and a \$100 Canlis gift card (the “Prize”) to the Winner of each Friday Night Bingo event. There will be one Winner each week. The Prize is provided without warranty. Any other cost or expense associated with the acceptance or use of the Prize not specified herein as being awarded, including, but not limited to, federal, state, or local taxes, are the sole responsibility of the Winner. All Prize details are at the sole discretion of Canlis. No transfer, assignment, cash redemption, or substitution of Prize is permitted, except by Canlis who reserves the right to substitute the Prize with one of comparable or greater value.

WINNER SELECTION. By participating in Friday Night Bingo, you agree to be bound by these Official Rules and to the decisions of Canlis, which will be final and binding in all respects. Canlis reserves the right (but is not obligated) to verify eligibility qualifications of the potential winners. Winners may be required to sign an Affidavit of Eligibility and Liability/Publicity Release. Canlis reserves the right, in its sole discretion, to void potential winners that are in violation of these Official Rules or believed to have attempted to tamper with or impair the administration, security, fairness, or proper play of Friday Night Bingo. Canlis reserves the right to extend the Giveaway Period, the dates for Winner

selection, and the timing of Winner notification at its discretion.

WINNER NOTIFICATION. The Winner each week will be notified by text message. Non-compliance with these Official Rules, the potential winner's failure to respond to the text message claiming the prize within five days of attempted notification, or return of the Prize notification as non-deliverable, may result in disqualification of the Winner and—at the discretion of Canlis—awarding of the Prize to an alternate winner.

ODDS OF WINNING. The odds of winning depend upon the total number of eligible participants participating in Friday Night Bingo.

ENTRY TERMS AND CANLIS' USE. By participating in Friday Night Bingo, you agree: (1) that Canlis will contact the Winners by text message; (2) that Canlis may contact you in the future regarding Canlis's promotions or offers; (3) that Canlis and its affiliates and subsidiaries, and each of their respective employees, agents or representatives (collectively the "Indemnified Parties"), will have no liability and will each be held harmless by you or any party claiming through you for any claim, action, liability, loss, injury, or damage to you or any other person or entity, including, without limitation, personal injury or death to you or any other person or damage to personal or real property, arising in whole or in part, directly or indirectly, by reason of the acceptance, possession, use, misuse or non-use of any Prize, or the participation or non-participation in Friday Night Bingo; (5) **that you waive all rights to claim from the Indemnified Parties any damages of any type, including without limitation, punitive, incidental, or consequential damages;** (6) to be bound by these Official Rules and the decisions of Canlis, which are final and binding on all matters relating to Friday Night Bingo; (7) to waive any right to claim any ambiguity or error in these Official Rules or Friday Night Bingo itself; (8) that Canlis is not responsible for taxes associated with winning a Prize in this contest; and (9) that the Winners may be required to provide certain tax related documents to Canlis as required by law before receiving a Prize..

RIGHT TO CANCEL FRIDAY NIGHT BINGO. If for any reason Friday Night Bingo is not capable of being run or implemented as planned (as determined by Canlis in its sole discretion), due to any reason including, but not limited to, tampering, unauthorized intervention, fraud, computer viruses or bugs, or any other cause of any kind, which, in Canlis' sole judgment, is likely to or actually corrupts, impairs or affects the administration, security, fairness, integrity, or proper conduct of Friday Night Bingo (including, but not limited to, tampering, unauthorized intervention, fraud, or any other cause of any kind), then Canlis reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend all or any part of Friday Night Bingo or to disqualify any implicated participant.

Any attempt to deliberately damage any website or undermine the legitimate operation of Friday Night Bingo is a violation of criminal and civil laws and should such an attempt be made, Canlis reserves the right to seek damages (including attorneys' fees) and other remedies from any such person responsible for the attempt to the fullest extent permitted by law. Canlis reserves the right, in its sole discretion, to disqualify any participants whom Canlis believes have attempted to tamper with or impair the administration, security, fairness or proper play of Friday Night Bingo or is in violation of these Official Rules, and void all associated bingo cards.

DISCLAIMER. Canlis is not responsible for late, lost, stolen, damaged, illegible, incomplete, misdirected, delayed, garbled, inaccurate, postage due or undelivered mail, or for telephonic, human, or computer failures, interruptions in service due to system upgrades, repairs, modifications, or other causes, failures or malfunctions of connections, satellite, network, cable, Internet Service Provider (ISP), phones, phone lines or telephone systems, traffic congestion on the internet, technical or mechanical malfunctions, or other malfunctions or errors, whether caused by equipment, programming, human error or otherwise relating to or in connection with Friday Night Bingo, including, without limitation, errors which may

UNFORSEEN CIRCUMSTANCES. The failure of Canlis to comply with any provision of these Official Rules due to an act of God, pandemic or similar virus outbreak, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, action of governmental authorities, or any force majeure event or event outside the control of Canlis will not be considered a breach of these Official Rules.

GOVERNING LAW; JURISDICTION; CLASS ACTION WAIVER. Friday Night Bingo is governed by the laws of the State of Washington, USA, without reference to conflicts of laws principles. As a condition of participating in Friday Night Bingo, PARTICIPANT AGREES THAT ANY AND ALL DISPUTES ARISING OUT OF OR RELATED TO THIS GIVEAWAY WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION, EXCLUSIVELY BEFORE THE STATE OR FEDERAL COURTS IN SEATTLE, WASHINGTON.
